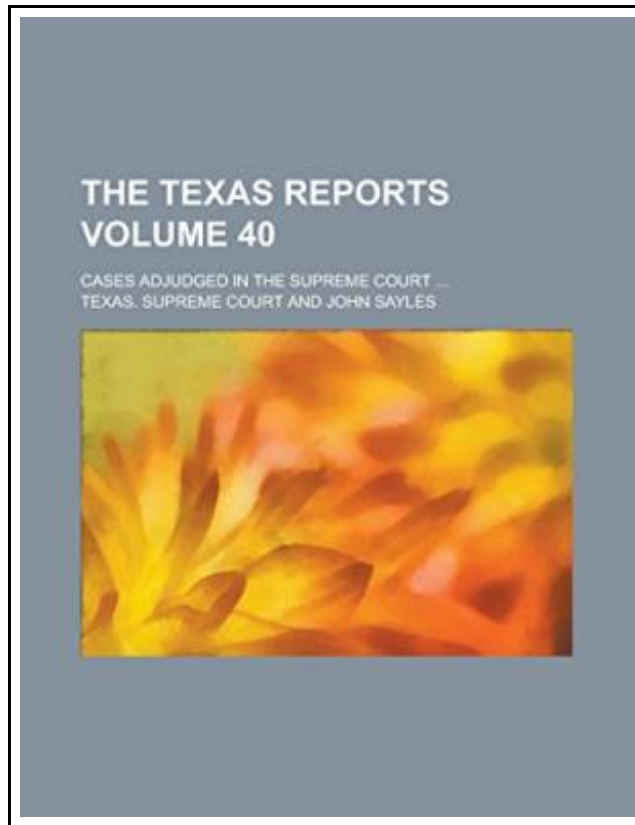

The question is not, must notice of appeal be given?--for that is.well established--but, how is that fact, which is of record in the court below, to be made known to this court? In an able and elaborate opinion delivered by Justice Gray (who is not now on the bench), it was stated that it should be made known to this court by a copy of the notice of appeal, inserted in the transcript just as it stands on the minutes of the court, and also by the certificate of the clerk, strictly in conformity to Article 1589, above quoted, stating the time when the appeal was perfected. (House Co. v. Burnett, ante, 346.) It was not necessary to have gone to that extent in that case, as there was no such copy of notice of appeal, . nor a proper certificate from which the court could be informed of that fact, necessary to the jurisdiction of the court.
