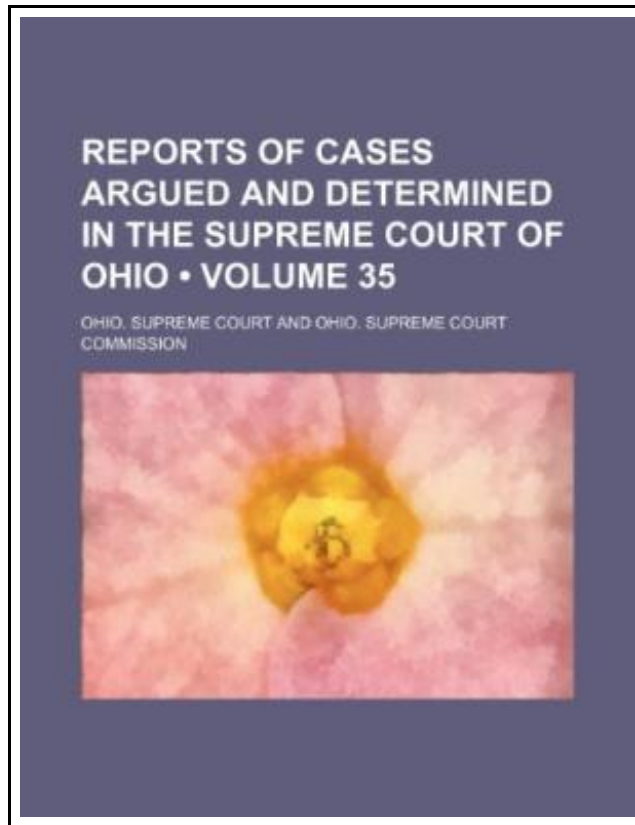

It is now moved by defendant in error that the proceedings in error be dismissed for the reason that the petition in error was not filed within three years from the date of the judgment sought to be reversed. Section 523 of the code (S. and C. 1106), provided, No proceeding for reversing, vacating, or modifying judgments or final orders shall be commenced unless within three years after the rendition of the judgment or making of the final order complained of, or, in case the person entitled to such proceeding be an infant, a married woman, a person of unsound mind or imprisoned, within three years, as aforesaid, exclusive of the time of such disability.
